**Approval of Minutes from Meeting of November 14, 2017:** No amendments or corrections. Steffen motioned to approve; McSweeney seconded; All in favor.

## **Chemistry/Biochemistry Minor Revision Proposal**

- Has not been popular historically, looking to increase the numbers
- The chemistry minor may become more attractive due to the new health studies minor, engineering students, and the new core revision
- Proposal:
  - o Replace CH 261 with CH 222
  - The change in curriculum will increase access to students
- Minors (although few) are usually biology majors or psychology majors

Motion to Approve: Steffen motioned to approve; McSweeney seconded; All in favor.

## **Sociology Minor Revision Proposal**

- Proposal: requirement change from 18 credits to 15 credits
  - Change in electives (one less)
- 18-20 students enrolled in the minor for the past five years
- This change will reflect requirements at other comparable schools that offer a sociology minor

#### New Course Proposal – CO 326: Palliative Care Communication: USA & Ireland

 One week intensive- study abroad and online taught by Professor Michael Pagano in the summer

- Connection with the only children's hospice in Ireland. Possible Service Learning Opportunity
- Team-Taught experience between Pagano and O'Shea (Nursing)
- Wills Not sure when and how often it will run
- Drake Seems like this course was crafted for a particular time and place but not taught as a special topics
- McSweeney Workload seems really intense
  - Wills it is a 300 level course so the department thinks it is appropriate.
     It is a month long course to complete the course work and final project.
- Steffen Who are the target students?
  - Wills Students interested in Health Studies

# Two New Biology Concentrations Proposal: (1) Health & Human Biology and (2) Evolution, Ecology, and Biodiversity

- Biology has two current concentrations: molecular biology and marine biology
- Health & Human Biology (set of four courses) will appeal to those who are prehealth students
  - o 70-80% of biology students are pre-health
  - They are essentially taking these four courses but the concentration will add a special designation on their transcript
- Evolution, Ecology, and Biodiversity (set of four courses two are set and the other two can be chosen)

- Smaller number of students
- Want to recognize them with the concentration
- The concentrations help student with post-graduate opportunities. It gives them a sub-specialization within the broad degree of biology.
- Concentrations are not required.
- McSweeney Can students do multiple concentrations?
  - o It is possible, it has not happened so far.
- All courses are currently offered, no additional courses or changes in curriculum or offerings. This just puts a label on what students are already doing.

### Discussion:

- McSweeney It needs to go through the process properly recommends it to be kicked back to the department. There are some topics that have not been addressed. (JoR, page 46)
- Steffen We can voice support. The essential information is there.
- Drake Can give it approval when the questions have been addressed as noted in JoR?
